- 1.The expenditure on this account will be met from the Head of Account 4202-02-104-99
2. A detailed Master plan should be prepared before starting construction.
3. The release of funds will be need based, when actual expenditure falls due.
- 4.Adhoc/Advance release of funds before expenditure becoming due will not be allowed..
- 5.Store Purchase Rules should be strictly followed in purchases.
- 6.Time of completion should be specified in the contract/MoU/Agreement. If accredited agency is executing the works, time of completion along with "penalty clause" should included in the Mou/Agreement.
- 7.PRICE software should be used in non-PWD works
